Warranty

Temisko (1983) Inc. " Temisko " warrants the new trailer to be free from defects in material and workmanship when properly maintained and used in normal service. Obligation under this warranty shall extend over a period of 1 year (12 months) following the date of delivery to the original purchaser and shall be limited to, replacement or repair of any parts found to be defective.

The Temisko warranty applies only to parts manufactured by Temisko. For all substitution made without written consent by Temisko, the warranty will be cancelled.

This warranty applies SOLELY to the first purchaser from the manufacturer or from an authorised dealer or distributor of the manufacturer.

"NORMAL SERVICE" means use of the trailer in an adequate manner concerning the loading and unloading system of goods, which does not subject this vehicle to exceed the weights normally imposed by lawful use on public roads, and gross vehicle weight rating (GVWR) and gross axle weight rating (GAWR) specified on the vehicle compliance plate.

Exclusions from warranty

This warranty shall not apply to:

1. Any trailer unit which has been altered after delivery in any way so as, after an inspection done by Temisko, to affect its operation or reliability, or which has been subject to misuse, neglect, or accident.
2. Any parts, accessories or components which are manufactured by others, in which case the warranty applies solely from these manufacturers.

Any parts which are subject to wear and while not defective are usually replaced during the warranty period under maintenance programs, including but not limited to seals, lamps, painting, brake system components, brake lining, brake drums, tires, replacement running gear components and the like.

Warranty claims

The purchaser claiming under this warranty shall contact our warranty department to obtain a purchase order so the requested repair may be carried out. We will not accept warranty bills, under any circumstances, that have not received our prior authorisation. Transportation expenses to the repair facility are to be borne by the purchaser.

Limitations of liability

At the exception of the above warranty, Temisko will not concede other warranties expressed or implied and all other obligations or liabilities on our part of any kind or character, including liabilities for alleged representations or negligence. We neither assume nor authorise any other person or agent to assume on our behalf, any liability in connection with the subsequent sale of the trailer unit.



It is agreed that Temisko, shall not be liable for incidental or consequential damages including, but not limited to, loss of income, damage to vehicle, attachments, trucks and cargo, towing expenses legal fees, and for the liability you may have in respect to any other person.

This warranty applies to any of all steel or aluminium/steel combination models built by Temisko.

Special recommendations

Temisko (1983) Inc. strongly recommend, with the intention of improving the performance of the trailer or semi-trailer you have recently acquired, to follow the instructions below:

1. Inspect and retorque all wheel nuts daily for the first 2 thousand miles (3200 km).
2. Check hub oil levels and pay attention to any leak that might occur, and this, every thousand miles (1600 km).
3. Inspect and retorque all bolts for torque rods and equaliser beams after a break-in of a thousand miles (1600 km).
4. Lubricate every slack adjuster and brake cam shafts.
5. Inspect and correct, if need be, axle alignment for the trailer or semi-trailer.
6. Retorque all bolts and fasteners paying particular attention to the axle U-bolts.

Verify again every 5000 miles or 8000 kilometers.

You have to take these instructions into consideration, in order to validate you warranty.

Electrical system

- Components, wire connections, junction box, 90 days no labour;
- Short-circuit or wrong installation, 6 months parts and labour.

Note : for bulb and regular sealed beam no warranty, except LED sealed beam.

Axle alignment, 90 days only.
